SECTION 1: GENERAL INFORMATION

1.1 Purpose

The intent of this Request for Qualifications ("RFQ") is to identify a Respondant who is qualified to provide services to Beach Cities Health District, a public agency that serves the cities of Hermosa Beach, Manhattan Beach and Redondo Beach, consistent with the scope of work included in this document.

Respondant must adhere to rigid performance standards that are mission critical to our agency's success. This document will provide Respondant with the information necessary to prepare and submit responses for consideration. Respondants to this RFQ are expected to provide Beach Cities Health District (hereafter referred to as BCHD) with information and evidence that will enable the evaluation of the experience and resources required for development and operation of a new 205,000* square foot (sf) Residential Care for the Elderly (RCFE) Building, if approved by BCHD, in a manner that best serves BCHD and the immediate surrounding communities. BCHD has the right to use any and all ideas presented in any response to this RFQ. BCHD reserves the right to issue this Request for Qualifications to qualified Respondants based solely on what it considers necessary to provide the greatest long-term benefit to BCHD and the best quality of service to the community and customers.

1.2 Beach Cities Health District Overview

The Beach Cities Health District (BCHD) is a dynamic public health agency serving the 120,000 residents of Hermosa Beach, Manhattan Beach and Redondo Beach through a wide range of innovative health and wellness programs that promote healthy lifestyles, physical health and fitness, and emotional balance. The organization strives to develop programs and services that meet our mission:

To enhance individual and community well being in the cities of Hermosa Beach, Manhattan Beach, and Redondo Beach through a broad array of innovative health services, collaborative partnerships, and community programs.

A tax-free public agency, BCHD spends over \$14 million annually for services for residents within the District.

SECTION 2: SCOPE OF SERVICES

2.1 Scope of Work

BCHD is seeking a partner to develop and operate an approximately 205,000 square foot (sf) RCFE Building with 157* new Assisted Living units and 60* Memory Care units on its Prospect Avenue campus in Redondo Beach, CA. BCHD intends to be a minority partner in the ownership of the RCFE Building and operations and will rely on the majority partner for assisted living and memory care development and operations.

The RCFE Building is the main component of Phase I of the proposed BCHD Healthy Living Campus Master Plan (HLC) for redevelopment of BCHD's 9.78-acre campus. Also envisioned for new development under Phase I of the HLC is 14,000 sf of space for a PACE (Program of All-Inclusive Care for the Elderly) Center*, 6,270 sf of space for Community Services*, and a 9,100 sf Youth Wellness Center*. Following the construction of the RCFE Building, the existing 158,000 sf Beach Cities Health Center would be demolished providing space for approximately 114,830 sf of open space*. Preliminary Phase 2 plans include a Wellness Pavilion of up to 37,150 sf*, an Aquatics Center of up to 31,300 sf (including 24,000 sf of indoor space and 7,300 sf of outdoor space)*, and up to 20,000 sf of space for the Center for Health and Fitness (CHF)*, which would be relocated back to the campus.

The HLC is undergoing environmental review pursuant to the California Environmental Quality Act, and is anticipated to be considered by the BCHD Board of Directors for certification later this summer. Separately, it is anticipated that Phase I plans for the HLC will be considered by the BCHD Board of Directors for approval in September 2021. Until completion of environmental review and approval by the Board of Directors, the proposed HLC is subject to modification in order to mitigate significant environmental effects and consider alternatives. Design and construction of the HLC will be through a Design/Build process that is expected to begin in late 2022.

BCHD is requesting interested parties to submit a Statement of Qualifications. Interested parties should have:

- RCFE, specifically Assisted Living and Memory Care, development, start-up and management experience;
- California presence; and
- Financial resources.

Statements of Qualifications are due on or before July 2, 2021. After reviewing Statements of Qualifications, BCHD will issue a Confidentiality Agreement and a Request for Proposal to selected Respondants by end of July, 2021. Requests for Proposal will be due September 3, 2021.

SECTION 3: STATEMENT OF QUALIFICATIONS FORMAT AND CONTENTS

To be considered, Respondant shall submit a complete response to this Request for Qualifications (RFQ) using the format outlined below.

3.1 Letter of Transmittal

The prospective Respondant's statement of qualifications shall include a brief letter of transmittal signed by an individual or individuals authorized to bind the prospective Respondant contractually.

3.2 Qualifications and Experience of Firm, Including Subcontractors

The statement of qualifications should address the following criteria:

RCFE, specifically Assisted Living and Memory Care, Development and Management Experience:

The Respondant shall provide information on their business, applicable certificates of recognition, licenses and other pertinent information that demonstrates their qualifications to develop and operate an RCFE Building with both Assisted Living and Memory Care components.

California Experience:

The Respondant should describe its California experience, including market coverage, locations and relationships with health systems,. The last item is a plus but is not a mandatory requirement if the Respondant can demonstrate that it has covered these issues and requirements in another location when developing and operating an RCFE Building with both Assisted Living and Memory Care components.

Project Team:

The Respondant shall designate a project team comprised of experienced professional and technical staff to competently and efficiently perform the work with their own personnel, Subcontractors, or commitment to hire additional staff. The response shall identify the project team's project leadership (i.e. principle, project manager), reporting responsibilities, and address how Subcontractors will fit into the management structure. As a minimum, the principle in charge and manager shall be designated. Other key personnel may also be designated. Information on education, training, certification, awards, etc. for project team members may be supplied. The manager must have adequate experience in managing the development of services of similar nature and scope.

Financial Resources:

Respondant should provide audited financial statements and supplemental financial information regarding operating performance, annual revenues and net assets for the most recent three fiscal years. Additionally, Respondent should provide data (occupancy levels and operating results) for a comparable stabilized RCFE Building with 150+ Assisted Living units and 50+ Memory Care units and

similar data (occupancy, move-ins, fill-up period, and operating results) for a start-up comparable RCFE Building.

Organizational Profile:

Respondant should describe its legal structure, ownership and affilates and how the proposed RCFE partnership would fit into that structure.

3.3 Required Disclosures

In addition to all other requests listed in Section 3 of this RFQ, Respondants to this RFQ will provide the following disclosure:

A disclosure of the Respondant's name and address and, as applicable, the name and address of any company or venture that owns or has majority stake in the Respondant and the names of key officers and directors of the Respondant.

A disclosure providing information regarding any major contract that has been terminated for any reason within the last 5 years by Respondant/or Subcontractors responding to this RFQ.

A disclosure that there are no known conflicts of interests by the Respondant or its Subcontractors and affiliates with BCHD or its affiliates, or any of BCHD's employees or Board members currently or any foreseen in the future.

3.4 Insurance Requirements

Please attach copies of all proof of insurance as described below that qualifies you to provide the service requested.

Respondant shall provide and maintain insurance coverage of adequate levels in compliance with the following as applicable:

- Worker's Compensation per California Requirements
- Comprehensive Public/General Liability \$2,000,000 per occurrence

Responses will be received and evaluated on the understanding that the Respondant accepts full responsibility for, and will be contractually bound by, all statements made within the proposal and by sales and/or technical representatives. This responsibility extends to verbal sales commitments, vendor literature and claims of the capacity and ability of the proposed Respondant and its representatives to meet the specified scope of service requirements contained in this RFQ.

The evaluation of Responses will include, but may not be limited to, the items listed in this RFQ. Additional significant consideration will be given to the quality and comprehensiveness of each Respondant's response to this.

BCHD reserves the right to accept responses in whole or in part, and to negotiate with any Respondant in any manner necessary to serve the best interests of BCHD. Respondants may be strictly held to the terms submitted in their responses as maximums, but may be required to reduce costs depending upon aspects of the services which may be determined by BCHD to be unnecessary, or aspects for which BCHD decides to assume the responsibility. The response submitted by any successful Respondant, and accepted by BCHD whether in whole or in part, will become part of the contract awarded as a result of this RFQ and the Respondant will be expected to sign a contract with BCHD, consistent with the RFQ, and such contract may include additional terms and conditions.

BCHD reserves the right to withdraw or cancel this RFQ at its own discretion. BCHD also reserves the right to reject any and all responses resulting from this solicitation. BCHD reserves the right to obtain any information from any lawful source regarding past business history and practices and the ability of Respondant to supply RCFE Building Development Services that BCHD has a right to expect from a Respondant with a good reputation. Such information may be taken into consideration in evaluating the responses.
